General Manager Report by Rob Walls:

June was another good financial month. EBITA of 44K of a budget of 17K. Annual EBITA is 219K for budget of 62K. We are doing Very well for the month. F&B was 15% over budget. Good trending numbers. It has been busier than ever at the Club. New membership Pace is slow for this time of year. Membership is healthy, our attrition is very low. Looking into incentive program but not touching or Changing initiation fees. Operations: we know come August we get into a staffing crunch but we are prepared for this. We are planning Ahead for that change in the season per Chef Adam and Maddie. Jasper will manage the pool through close time, and we will keep her Engaged through the off season by working with F&B. LFCC is hosting the Twin City this coming up weekend. CCC told us they cannot Host LFCC members this year due to apparent conflicts. 19th hold AC system not working perfectly. Lanz was out to service our unit.

It was overloaded and turned itself off. This unit was fixed. Running properly and efficiently. We are looking at the two units that control The 19th hole area, and the larger unit that services the kitchen. We are going to, in the off season, look at making all units work efficiently.

We will also be looking at AC efficiency in the office spaces in the downstairs area of the Club, also in the off season. We did some kitchen Repair work for leaking pipes and that was solved quickly and well.
