General Managers Report- Rob

April was a solid month. Revenues slightly outpaced the budget. We are slightly behind on the dues line. Easter fell in April this year compared to March in the past several years, which affected our bottom line for the month. Golf rounds are down 18.4% so far this year. Weather has really hampered membership's ability to get on the course early this year. We have moved to a contract cleaning service which will give us a more consistent service throughout our facilities. Due to the ongoing pool leak we anticipate a significant increase in our water bill as well as repair costs to solve the problem.

Mackenzie Bertrand joined us on May 13th as our new marketing director. All other departments are well staffed. We have 22 lifeguards on board for the season. Jasper is returning full-time as our aquatics manager

As of April 2025, we have sold 19 new memberships. With the pool opening we will see more interest in potential new memberships. Membership attrition remains an area of concern. There has been an increase from the previous years. With the pool opening, we expect the month of May to finish strongly.

Pool leak update: We are still losing water. We have a specialist in this field coming from Carmel, IN on Wednesday May 21st. He will be performing a test to identify where the leak is. The next step will be to determine how to fix it with the least amount of disruption to our membership.

Old Business:

Tennis update: The first binder of asphalt was put down on Monday, May 20th. Progress has been slower than we would have liked. The rain has hampered our progress. S & K will be out to begin fencing soon. We will not meet our initial target date of Memorial Day completion. An update on the progress will be sent to the membership along with information about the progress on the project and will include our new target completion date.
